PLEASE TAKE NOTICE that, at 11:00 a.m. on March 28, 2023, at the United States District Court for the Southern District of New York, Daniel Patrick Moynihan Courthouse, 500 Pearl Street, New York, New York 10007, in the Courtroom of the Honorable Naomi Reice Buchwald or by such other means as the Court may designate, Counsel for the Settlement Classes will, and hereby do, move the Court, pursuant to Federal Rule of Civil Procedure 23(e), for an Order: (i) granting the request of counsel for the Bondholder settlement classes (“Class Counsel”) for attorneys’ fees in the amount of 28% of the net settlement funds, or \$489,720.00; (ii) granting Class Counsel’s request for reimbursement of litigation expenses in the amount of \$1,556.00; and (iii) granting Class Counsel’s request for service awards in the amount of \$2,500.00 each for the two Bondholder Plaintiffs, Ellen Gelboim and Linda Zacher.
